



MIRDC 產品驗證認可登錄標誌使用規範

1. 前言：

Preface

為便於廠商展現其產品已通過本中心之產品驗證認可登錄，並期保障登錄廠商、採購商及消費者之權益，特設產品驗證之認可登錄標誌(以下簡稱登錄標誌)並訂定使用規範，據以使用。

In order to show the status of product certification, the use of product certification mark and its identification are defined in this specification.

2. 圖式繪製方法及使用

Method of Drawing Product Certification Mark and the Identification number

2.1 圖式及識別號碼製作範例

Examples of product certification mark and the Identification number are shown as followings.

2.2 不予指定固定尺寸，但應以適當(方格子)比例大小標印於產品本體上。

There is no size restriction on the Mark, but the Mark shall be affixed to the body of the product in appropriate proportion (please see mark in grid).

2.3 由產品驗證已登錄廠商自行印製之產品驗證標識，應使用不易變質之材質製作，內容清晰可辨且不易磨滅，並以永久固定方式標示。

The obligatory applicant shall use non-degenerate materials to print/produce the product certification mark and the Identification number, which shall be affixed to each product in a visible, legible, indelible and immovable manner.

2.4 商品之其他標示不得與產品驗證標識混淆，或使消費者不易辨別商品檢驗標識。

The affixing of other markings on the product, which are likely to mislead or confuse the consumers or the third parties, shall be prohibited.

2.5 產品驗證標識應標示於商品本體。但商品本體太小無法標示時，得依下列方式標示之：

The product certification mark and the Identification number must be affixed to the body of the product. However, if the product is too small to accommodate the Mark, the product certification mark and the Identification number shall be affixed in accordance with the following ways.

2.5.1 具有包裝者，於最小單位包裝標示之。

If the product has its packaging, it shall be affixed to its smallest package.

2.5.2 無包裝或其包裝不適宜標示者，以繫掛方式標示之。

If the product has no packaging or it is not appropriate to affix the Mark on the packaging, it may be attached to the product by hanging tags.

2.5.3 包裝標示或繫掛均不適宜者，置放於包裝內。

If the ways of affixing to the packaging and hanging tags are not appropriate, it shall be put inside the packaging.

2.5.4 以其他經金屬中心同意之方式標示之。

Other amendable ways approved by the MIRDC.

2.5.5 前項產品驗證標識方式，應標示於商品明顯處，使消費者於購買或使用時能清楚識別。

The product certification mark and the Identification number should be affixed at a conspicuous location on the product in order for the consumers to identify it when they buy and/or use the product.

2.6 登錄廠商使用本中心之標誌及產品驗證標識時，不得使登錄標誌模糊不清或在正常視力下無法辨識產品驗證登錄識別號碼。

The affixing product certification mark and the Identification number should be clearly visual identified.

2.7 登錄廠商經撤銷或廢止產品驗證認可登錄，或產品驗證登錄範圍遭縮減時，登錄廠商應：

If the product certification is not valid or the scope of product certification is changed, the applicant shall

2.7.1 立即停止使用登錄標誌，或針對遭縮減之範圍停止使用登錄標誌。

Stop to use the product certification mark and the Identification number or only use the product certification mark and the Identification number within available scope.

2.7.2 立即塗銷或去除之登錄標誌及相關識別號碼。

Delete/Erase already used product certification mark and the Identification number if it is not available.

3. 產品驗證標識違規處理

Response if the applicant is against the specification

- 3.1 廠商透過出版品、電子媒體或其他方法，使用驗證標識進行宣傳時，不得有不正確引用產品驗證登錄事項或誤用產品驗證標識之情事(如令人有誤解之行為)

The use of product certification mark and Identification number shall not misleads it if the advertisement of product is through publication, electronic media or other means.

- 3.2 登錄廠商若違反上述使用規定，應發函通知廠商改正；經通知後仍未改正者，將依個案情況專案處理，最嚴重者得廢止其認可登錄。

MIRDC shall notice the applicant not to misuse it if the applicant is against this specification of product certification mark and Identification number. The applicant shall take the corrective action. The action shall be taken by MIRDC for the registration of product certification if the applicant doesn't response after noticing. The validity of registration may be taken into consideration.

- 3.3 未依本中心產品驗證系統規定之符合性評鑑程序取得證書，逕行冒用或偽造使用驗證標識者，移送司法機關辦理。

The product certification mark and Identification number shall be authorized to use through the conformity assessment procedure of MIRDC. The one, who fakes the product certification mark and Identification number or use product certification mark and Identification number without authorized by MIRDC, shall take legal responsibility. Prosecution shall be taken if unlawful use.
